In addition, over 50% of the FUCHS production plants are certified according IATF 16949, 65% hold an ISO 14001 certificate and over 40% are certified according ISO 45001 (or the former OHSAS 18001). For the future, the FUCHS Group strives to certify all sites according to the ISO 14001 and ISO 45001 standards.

All by FUCHS marketed products fulfill the relevant international standards and applicable market specific requirements, e.g. OEM (Original Equipment Manufacturers) requirements. Our formulations are based on globally approved raw materials maintaining the consistency of the performance of our products worldwide.
